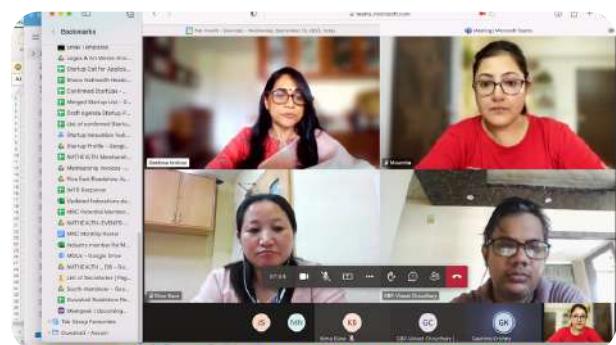

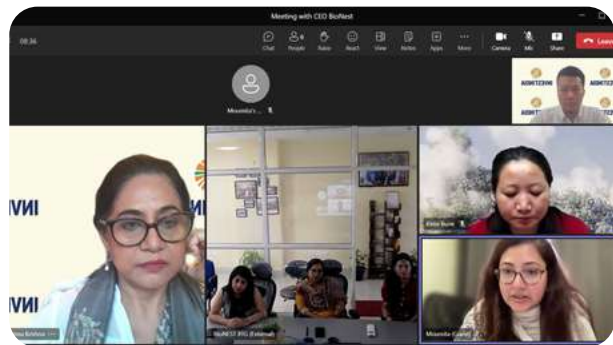

Western Region meeting

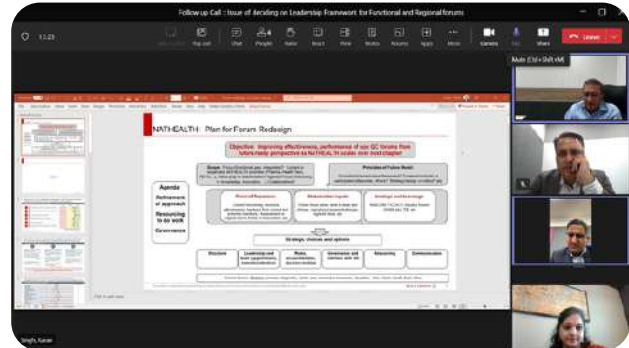
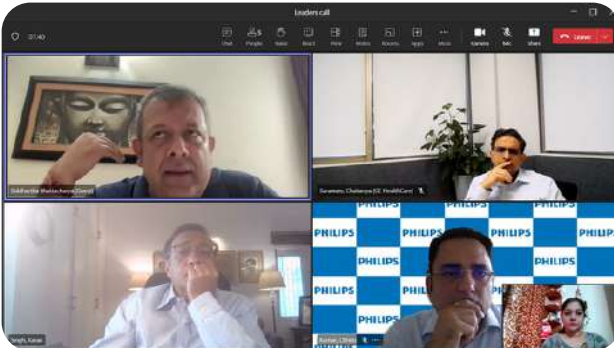

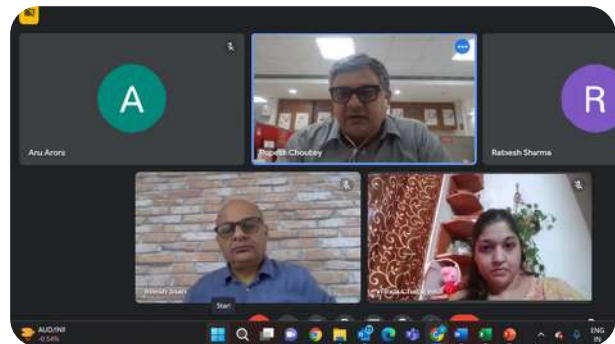
Diagnosics Forum meeting

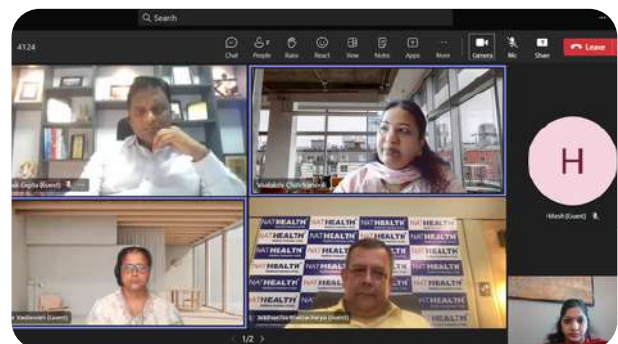

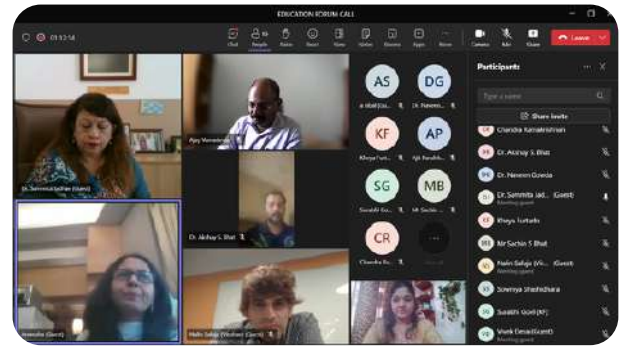
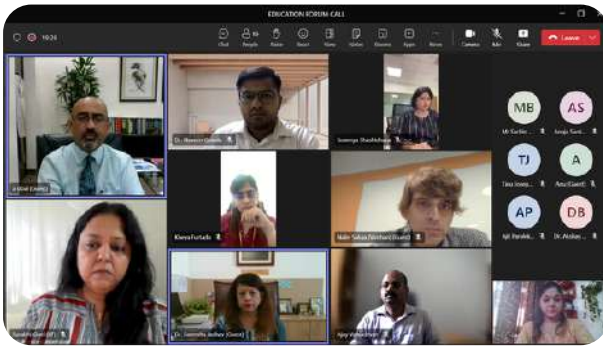
Treasurer Meeting

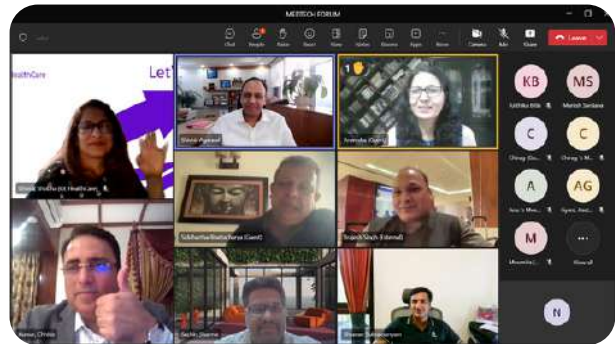
Digital Forum meeting

Climate-conscious investments in health

Every year, environmental factors cause about 13 million global deaths, constituting one-fifth of total fatalities and underlining the threat that environmental issues pose to health. But less than 2 per cent of multilateral climate funding is directed towards tackling these challenges. The relationship between climate change and health is intricate. Transport and industrial expansion emit pollutants that drive air pollution, and extreme weather events leading to widespread illness and displacement. This interdependence also opens avenues for health co-benefits, by establishing a synergy between addressing climate change and advancing health outcomes.

Around 4.5 percent of global greenhouse gas (GHG) emissions stem from the healthcare industry, primarily driven by supply chains (60-70 per cent), energy sources (10-15 per cent), and healthcare facilities (15-20 per cent). So addressing climate change within healthcare promises considerable health advantages, encompassing shifts towards plant-based diets, enhanced housing with better ventilation and waste management, promotion of low-emission transportation modes and adoption of renewable energy sources and energy-efficient appliances.

Investors encounter diverse opportunities in this evolving domain. Modern healthcare models that amalgamate mitigation and adaptation strategies offer investment potential, aligning with sustainability demands and providing prolonged financial gains. By prioritising environmentally conscious practices and technologies, investors wield the power to mould a more sustainable and robust healthcare sector.

Opportunities for climate-conscious investments abound across various healthcare segments — within hospitals and diagnostics, possibilities lie in digital therapeutics, virtual care, home healthcare services, and AI-driven diagnostics. Pharmaceutical and medical device sectors offer room for eco-friendly packaging, health-monitoring devices, green chemistry models, IoT energy trackers and sustainable supply chains. Such investments are pivotal, holding the potential to establish a mutually reinforcing cycle that leads to a healthier planet and a more resilient healthcare sector for future generations.
