Overview of the Eastern Region Roadshow: Siliguri Dialogue

Promoting Awareness and Information Dissemination: Joint campaigns to raise awareness about existing PPP schemes, addressing the lack of information among stakeholders about available healthcare initiatives in West Bengal.

Overcoming Compliance Roadblocks: NATHEALTH and stakeholders to advocate for the rationalization of compliances and regulatory processes, identifying and resolving roadblocks hindering efficient healthcare service delivery.

Advocacy for Effective Payment Modes: Promotion of discussions on suitable and sustainable payment modes for PPPs, advocating for transparent and efficient payment mechanisms to ensure the success of healthcare PPPs in West Bengal.

Tackling Talent Shortages: Collaborative efforts to address acute shortages in medical professionals, technicians, and allied healthcare staff, exploring strategies to attract and retain talent in Tier 2-4 cities.

Strategic Financing and Investment: NATHEALTH and stakeholders can jointly explore financing options to overcome challenges related to high capital expenditure and operational costs, attracting investments and ensuring a clear return on investment.

Promoting Ease of Doing Business: Collaboration to enhance the ease of doing business in the healthcare sector, advocating for streamlined processes, online platforms, and supportive policies to encourage private sector participation in West Bengal.

Facilitating Collaborative Opportunities: Continued efforts to identify and promote collaborative opportunities among healthcare stakeholders, fostering a collaborative ecosystem for mutual benefit and advancement of healthcare services in West Bengal.
